About Us

The University of South Florida Libraries accelerate learning and knowledge production through distinctive collections, information service innovation, and thought leadership. We are one library serving three diverse communities: USF Tampa, USF St. Petersburg, and USF Sarasota-Manatee.

USF Tampa Library

Centrally located on campus, the Tampa library serves as USF's main research library. An inviting and collaborative place to meet, study, and conduct research, the library offers students access to an extensive selection of print and electronic books, maps, journals, databases, and textbooks. Featuring a variety of study rooms and collaborative and quiet floors, a Graduate Reading Room, an IT Help Desk and Computer Repair, SMARTLab, Writing Studio, Academic Success Center, Office of High Impact Practices and Undergraduate Research–as well as a Starbucks Coffee–the library is a truly student-centric facility.

USF St. Petersburg's Nelson Poynter Memorial Library

The Nelson Poynter Memorial Library, located along the waterfront of the St.Petersburg campus, promotes and supports faculty and student-centered learning and research in an inviting, creative, and flexible environment. The library offers a variety of study and collaborative spaces, access to print and electronic resources, textbooks, printers, and more. Technology support is available through the Student Technology Center, which also features a maker-space with access to 3D printing and VR technology tools.

USF Sarasota-Manatee Information Commons and Library Services

The Information Commons and Library Services at the USF Sarasota-Manatee campus partners with faculty, academic, and student units across campus to teach students information literacy and research skills, as well as coordinate loans of essential technology tools and library resources/course reserves. Additionally, the Sarasota-Manatee library provides specialized data, research, and collections services in support of Sarasota-Manatee campus faculty and student research, impact, and visibility.





Tampa Renovations

Changes On Tap for USF Tampa Library Building

Times really have changed since the Tampa campus library opened in 1975. To provide some context, 1975 was also the year Microsoft was founded. In its lifetime, the building has seen the advent of computers and cell phones, as well as the demise (and recent resurrection) of Disco. Perhaps the biggest change, though, is the number of people the Tampa library has come to serve.

As USF's Tampa campus has grown, so have the library's collections, services, and spaces. To keep up, we're excited to be working toward changes that will keep the heart of USF Tampa operating at full capacity for students, faculty, staff, and our community.

Our facilities and operations staff have taken a close look at how best to serve our patrons, and the answer was a more secure experience within such a large building. To support these efforts, a new security system will be installed beginning Spring 2024. The major highlight of the system is high tech turnstiles (think Tampa airport, not New York City subway) which will require a valid USF ID for entry. The same turnstiles will also be installed at USF St. Pete's Nelson Poynter Memorial Library.

This and additional changes will:

- Increase egress more than 100 percent
- · Restrict entry to authorized/approved visitors
- · Increase safety and security in library open spaces

These changes will take some time to install and affect the building's entrance for up to a year. The good news is this also gives us time to explore more ideas, including the possibility of adding a police sub-station on the ground floor to better serve our surrounding area.

Finally, the changes to the building will also extend to the open areas outside of the main entrance, which we plan to convert into more usable space for our campus community.



NPML Renovations

Nelson Poynter Memorial Library first-floor renovation

The first floor of Nelson Poynter Memorial Library (NPML) was renovated and reopened in January 2023. The renovation included a new atrium, 12 new study rooms, an updated Student Technology Center and Makerspace, and a reimagined NPML Gallery.

The new atrium is a bright and welcoming space that is perfect for gatherings and events. The new study rooms are spacious and well-equipped, and the updated Student Technology Center and Makerspace offer students a variety of resources to help them with their studies. The reimagined NPML Gallery is a place to showcase the library's collections and to host exhibits and events.

The renovation of the NPML first floor is a major investment in the library's future. The library is now a more welcoming and inviting space for students, faculty, and the community. It is also a more flexible space that can be used for a variety of purposes.

In addition to the physical changes, the NPML has also launched a number of new initiatives as part of the renovation. The PlaceMatters SP lecture series, in partnership with Preserve the 'Burg, will explore the relationship between space and place, and the library is also planning to host a variety of other events and programs throughout the year.

The renovation of the NPML first floor is a major step forward for the library. It is a space that will be used and enjoyed by people of all ages for years to come.

Digital Collections

Prominent new projects for the team included joining the Florida Ornithological Society (FOS) as the production editor and host for the Florida Breeding Bird Atlas II and developing the grant-funded open-education resource, EcoLiteracies for Climate Action in Florida. In addition, Digital Collections began working with USF Communications and Marketing on their data management processes to develop an archive of born-digital USF Photographs.

Breeding Bird Atlas II


The Breeding Bird Atlas II from the Florida Ornithological Society (FOS) is a special publication of FOS, which has been formatted, hosted, and archived by the University of South Florida Libraries. Grid-based atlases are efforts to document systematically the occurrence of plant or animal species within a given area. ELCAF Portal

The Eco-Literacies for Climate Action in Florida (ELCAF) is a collaborative grant-funded project co-lead by Dr. Alexandra Panos, College of Education, and Dr. Amanda Boczar, USF Libraries. ELCAF pairs ecologically-focused stories with archival materials exploring Florida's environment and natural history for learners of all levels. **Area(s): FLENH, Florida Studies, CYAL**





Operations

During FY 2022-2023, print books remained a useful resource with 40,077 loans, including those made at service points and those used in-house. With USF's growing collection of e-book content, which provides research material that can be accessible from anywhere on campus, USF faculty and graduate patrons continued to indicate the need for print materials.

The "Loans By Patron Type" chart includes traditional loans as well as "In House Loans." In House Loans are made when a patron pulls an item off the shelf and then returns it to one of the re-shelving stations, without leaving the library or requesting that the item be checked out to them. Because of this, these items are not checked out to a specific patron and thus provided with an "unknown" patron type.


In FY 2022-2023, the USF Libraries implemented OpenAthens authentication, allowing direct login to electronic resources and providing a basis for improved statistical reporting. As part of this effort, our staff worked closely with the university's Information Technology group to enhance patron data load management.

Workshops for Researchers

During FY 2022-2023, the Workshops for Researchers program, which is research skills-based virtual instruction, experienced healthy growth. It reached close to 1,000 participants, of which 48% were graduate students and 21% were faculty. In total, librarians provided 1,042 in-depth research consultations to faculty (36%), graduate students (34%), and undergraduate students (24%).

Special Collections

Collection Highlights, Tampa

During FY 2022-2023, 22 unique donations of archival and print resources covering contemporary teen fiction, regional investigative research, environmental activism, and art and humor in the United States were received from 17 established and new donors. Special Collections also formed new partnerships that inspired more extensive collaboration between the USF Libraries and two state organizations—the Florida Audubon Society (FAS) and the Florida Ornithological Society (FOS). Formal partnership agreements with the FAS and FOS led to the acquisition of organizational records, images, audiovisual materials, and maps; supported the Libraries' active participation in Society events; and generated online exhibits and related projects led or sponsored by Special Collections. Active relationships with the Florida Audubon Society and Florida Ornithological Society supported the USF Libraries' documentation of Florida's natural history and environment and contribute to Special Collections' overall curation of ornithological resources in the state of Florida.

In addition to the FAS and FOS collections, this year's featured resources also included the African American Burial Grounds Oral History, the Audubon Oral History Project, and the papers and print collection of Sally Thompson.

African American Burial Grounds Oral History

The African American Burial Ground & Remembering Project is an ongoing USF research study led by Dr. Antoinette Jackson (USF Department of Anthropology) that addresses the erasure of historic black cemeteries in the Tampa Bay area.



Audubon Florida Maitland Records

In March 1900, the state of Florida's Audubon Society met in Maitland, FL for the first time to discuss Florida's wading birds, which were being decimated by plume hunters. Since then, Maitland has served as a hotbed of Audubon activities in Florida, including its longtime state headquarters (between roughly 1957 and 1995), the highly effective Eagle Watch program, and the Center for Birds of Prey. The Society's organizational records cover a broad variety of conservation topics, including Everglades restoration, bird banding, land and water use, field trips, birds of prey, manatees, alligators, and too many bird species and Florida place names to list here.

Florida Ornithological Society Archives

The Florida Ornithological Society (FOS) archives covers more than 50 years of correspondence, photographs, bird counts, bird banding records, newsletters, field notes, films, and administrative records.

In FY 2022-2023, the St. Petersburg campus' Special Collections and University Archives unit specialized in St. Petersburg, regional, and Florida history, and on the African American experience in the Tampa Bay area. Notable current and emerging archival collections and significant community partnerships included the Weekly Challenger Digital Newspaper Archive, a publication documenting the city's African American community since 1967; the Bob Devin Jones-Studio@620 Digital Collection seeking to tell one part of the story of St. Petersburg's transformation into a city of the arts through the work of the Studio and its co-founder/artistic director; and the Peter Belmont - Preserve the 'Burg collection, which will document local historic preservation efforts within St. Petersburg and Pinellas County.

Collection Highlights, St. Petersburg

Preserve the 'Burg Partnership & Belmont Papers

The Nelson Poynter Memorial Library is honored to be the new home for the papers of Preserve the 'Burg founding board member Peter Belmont. According to PTB executive director, Manny Leto, the collection documents "Peter's and Preserve the 'Burg's decades of work to preserve the city's historic resources and the growth of St. Pete since the 1970s." Although the papers are currently being processed, a first-floor library display case has been created to introduce the collection and the library's partnership with Preserve the 'Burg.







Textbook Affordability

The Textbook Affordability Project (TAP) has taken multiple approaches over the years to promote textbook affordability and cost-saving solutions for students at USF, and the following four strategies had the greatest impact on average undergraduate textbook cost per credit hour reductions: (1) advocating for the faculty adoption of the lowest-costing format of an instructional material, often opting for the digital version of a title.

For example, a \$300 print textbook could be obtained for as little as \$50 in its digital form; (2) encouraging and facilitating the usage of open access textbooks; (3) collaborating with the USF Bookstore to explore affordable textbook options for courses; (4) and increasing faculty awareness of available library resources, such as the USF Libraries catalog and Ebooks for the Classroom+ program.



Textbook Affordability

Since its inception in 2009, the Ebooks for the Classroom program has been dedicated to providing faculty-requested e-books through the USF Libraries at no cost to students. These e-books serve as required or recommended readings and are accessible across all USF campuses. In 2017, the program evolved into the Ebooks for the Classroom+ (EB+) database tool, offering an extensive collection of over 700,000 e-books for adoption in USF courses. USF faculty can easily adopt library-supplied e-books from EB+, which come with minimal restrictions on use, such as printing, downloading, and simultaneous usage, making them a convenient and free alternative to traditional textbooks. As a result, students enjoy instant access to materials without incurring any expenses. The program has made a significant impact on textbook affordability at USF over the years, saving over 125K students a total of \$8.2M from 2016 through 2023.

In FY 2022-2023, the Ebooks for the Classroom+ program was able to save 29K students a total of \$2.3M.

The USF Libraries added a number of ebook collections, journal archives, and other digital curated archival collections to its portfolio of e-resources which support a variety of subjects including Humanities, Social Sciences, and STEM subjects areas. INSTITUTIONAL COMPARISON

OVERVIEW

Membership in the Association of Research Libraries (ARL) is a central goal of the USF Libraries. Membership is granted to the institution in recognition of their libraries' contributions to the scholarly environment in several dimensions: breadth and quality of collections and services; leadership in the profession and across the institution; and innovation. The institutions' profile is another important component of the membership decision: ARL libraries support institutions emphasizing research and doctoral level graduate instruction.

The process of membership evaluates three primary criteria:

- similarity of the parent institution to ARL institutions;
- similarity of size as determined by a factor analysis of data describing the library's collections, staffing, and financial support; and
- collections of distinction.

The data presented below was drawn from institutions admitted to the Association of American Universities (AAU) within the last ten years and Virginia Commonwealth University (VCU). The variables included total library expenditures, material expenditures, professional staff salaries, professional and support staff FTE, number of library professionals to instructional faculty, number of library professionals to graduate students, and collection expenditures per graduate student.





Total Library Expenditures




Library Material Expenditures

Professional Staff Wages/Salaries (Faculty & A&P)





Total Professional and Support Staff FTE








Ratio: Instructional Faculty to 1 Library Staff


FY 2022-2023

OVERVIEW

In FY 2022-2023, the USF Libraries, excluding the Shimberg Health Sciences Library, expensed about \$21.4M in total. This included one-time funding received to support annual cost increases to library resources, costs to support personnel salaries and benefits, temporary personnel support, library resources, services to the library, supplies, and other expenses. These costs were necessary to ensure that the Libraries could function effectively and provide the necessary services and resources to its patrons. The sources of funding available to the libraries were: education & general (E&G), which included general revenue and lottery funding; sponsored research awards; contributions to the libraries through the USF Foundation; research initiative accounts (RIA) from Facilities & Administrative (F&A) cost distributions; funds from the financial aid federal work study program; and auxiliary funds which generated revenue by providing goods and services.




FY 2023-2024

OVERVIEW

FY 2023-2024 budgeted expenditures are \$21.9M, which included an anticipated annual cost increase to library resources and strategic investments in new library resources and a new data management platform. There were several factors that influenced our budget, which included our ability to generate and receive revenue to support operations, changes in service levels to library patrons, the impact of inflation on library resources, personnel salaries and benefits, maintenance costs, and other services. The USF Libraries remained committed to its mission and continuing the ongoing process towards our goals.
